The CancerStats information and reporting portal is the repository for all feedback on those national datasets, which are managed or supported by the National Cancer Registration and Analysis Service (NCRAS).

- This includes the Cancer Outcomes and Services Dataset (COSD); one of the main data sources for the NABCOP's reporting. Completeness and quality of these data are therefore paramount to publishing accurate information.




